

2. The promotion will be effective from the date of assumption of charge of the new post till further orders. It is also stated that ad-hoc promotions are being made purely as a temporary measure and as a stopgap arrangement and can be withdrawn / cancelled at any time without assigning any reasons. The promotion will not bestow on the above mentioned officers any claim for regular appointment and ad-hoc service will not be counted for the purpose of seniority in that grade and for eligibility for promotion etc.

3. The above promotions shall be effective from the date of assumption of the charge. Persons who have been posted at new station shall have to move to the new place immediately failing to which it would be treated as refusal of promotion and MACPs granted to them are liable to be withdrawn.
