ORDER

Subject: Grant of Modified Assured Career Progression (MACP) to SI Grade II of SSS.

In pursuance of DOP&T's guidelines on MACPs and on the recommendation of the Screening Committee, fifth meeting of which was held on 28th January 2010 and 9th February 2010, the Competent Authority has approved grant of 1st and 2nd in Grade Pay of Rs. 4600 and Rs. 4800 in Pay Band -2, on personal basis, to **Statistical Investigator Grade II** of Subordinate Statistical Service (SSS) who have completed 10 and 20 years or more than 20 years of regular service on or after 1.9.2008 as per details given below:


